WHEREAS individuals and organizations from a multitude of disciplines across Alberta are working together to increase awareness of this issue and encourage Albertans to take steps to prevent falling; and

WHEREAS the quality of life is improved for Alberta seniors who remain healthy, active and independent;

NOW THEREFORE, I, Mayor Robert Aellen, do hereby proclaim the month of November 2014 to be **Seniors' Falls Prevention Month** in Elnora, Alberta. Carried.

Costs to extend the service to the Mose property will be estimated and communicated. Conditions of use as in *Res #07-41-41* remain unchanged.
- 6.5 Annual Organizational Meeting date to be advised and will be before November 3rd.
- 6.6 FCSS Cost Share for 2015 to 2017 Elnora portion increased by \$3500. FCSS worker hours increase to 30 per week from the current 20. Impact on the 2015 budget will be minimal as the increased cost is offset by the reduction in funding the Community Engagement Site.
