

BYLAW NO. 2019-03

VILLAGE OF ELNORA

PROPERTY TAX BYLAW

A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE VILLAGE OF ELNORA FOR THE 2019 TAXATION YEAR.

WHEREAS, the Village of Elnora has prepared and adopted detailed estimates of municipal revenue, expenses and expenditures as required, at the special meeting held on May 27th, 2019; and

WHEREAS, the estimated municipal revenues from all sources other than property taxation total \$433,226; and

WHEREAS, the estimated municipal expenses (excluding non cash items) set out in the annual budget for the Village of Elnora for 2019 total \$675,388; and the balance of \$245,162 is to be raised by general municipal property taxation; and

WHEREAS, the estimated amount required to repay principal debt to be raised by general by general municipal taxation is \$0; and

WHEREAS, the estimated amount required for current year capital expenditures to be raised by general municipal taxation is \$0.

WHEREAS, the estimated amount required for future financial plans to be raised by municipal taxation is \$0; and

THEREFORE the total amount to be raised by general municipal taxation is \$238,503;and

WHEREAS, the requisitions are:

WHEREAS, the Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the *Municipal Government Act*, Chapter M-26, Revised Statutes of Alberta, 2000; and

WHEREAS, the assessed value of all property in the Village of Elnora as shown on the assessment roll is:

NOW THEREFORE, under the authority of the *Municipal Government Act*, the Council of the Village of Elnora, in the Province of Alberta, enacts as follows:


2 That this bylaw shall take effect on the date of the third and final reading.

READ a first time on this 27th day of May, 2019.


READ a second time on this 27th day of May, 2019.
